An Eclipse Macro to Recall Previous Exhibit Number

Back in Tip #34 (Feb. 2004), I wrote about three-step autoincludes. The idea was that instead of using one block file that had a blank that you would later fill with an exhibit number, you could break that into three steps. Here's my steno example, but an EclipseVox user could produce the same result with voicesteno commands:

MARK/MARK: {**P**}{(^}

Steno/Dictation: Exhibit 7 (or any other text)

MARKD/MARKD: marked{^)}

The end result (**Exhibit 7 marked**) would require no editing and would display perfectly on realtime client screens.

In a recent rather hurried deposition, the attorney was marking exhibits out of order and would ask me what was the last exhibit number. I really wanted to get a bit snippy and say, "I'm just trying to keep up with what you're saying. I cannot simultaneously recall your non-sequential exhibit numbers." Anyway, that prompted me to look for a macro to go back in my text, find the last spot where my three-step process had ended with "marked)" and copy that info onto a Comment line at the bottom of my screen.

During realtime transcription, I can now write PRAOEF/PRAOEF, and the result is a comment line at the bottom of my screen, like this:

Co: Previously: (Exhibit 7 marked)

I will make this macro available in a .MAC file that you can download from the e-Tips page of KVincent.com. You can go to User Settings, Edit, Macros, and use the "Import" button to add that macro to your own list. You will then need to "Edit" that macro and use the "Dict Entry" button to indicate your steno or voicesteno that will invoke the macro. This does presume that you will use my three-step process when an exhibit is marked. However, the macro should work on any version of Eclipse, even going back as far as the year 2000.

Eclipse10: Bridge Mobile Quick Links

Today's tip is meant to accompany a Visualizer that Keith has prepared for Eclipse Version 10. You can download that movie at the e-Tips page of his website: KVincent.com.

Eclipse v10 makes it really easy for clients to connect to y o u r r e a l t i m e transcript in Bridge Mobile. Just generate a Quick Link, then send the link via e-mail. The link embeds the document name and password. Super easy.

Of course, you can create these links and paste them into an e-mail message as soon as you start realtime translation, but you do not have to wait until the last moment. **You can prepare the link ahead of time, by choosing "Virtual Realtime**" in the "Translate Notes" dialogue (Alt+T).

When asked for the file to be translated, any name will do because **the name that matters is whatever you type as "Document name" in the "Sessions settings" dialogue.** In the example above, I typed "Today" as the document name, and I indicated a password. When the time for realtime proceedings comes, the link that you created ahead of time will work, as long as you remember to use that same "Document name" and that same password.

After you use the OK button on the dialogue, your Quick Link is ready to be copied into an e-mail message. It's a good idea to send

yourself an e-mail that contains the link so that you can test and make sure it works properly, as shown in the Visualizer.

Also, the Quick Links are not just for clients who will be connecting via the internet. This also works with the "LAN" option (Connection Magic Local). You can even open the "Print Commands" dialogue, choose "Graphic" and paste the link into the box for creating a QR code. With that code on your screen, you use the camera of your iPad or tablet to scan the QR code and get an instant connection to your realtime transcript.

This is definitely a feature that is easier to use than to describe, so check out the Visualizer that Keith has made available on his website: KVincent.com.
