Wil's e-Tip

Customize the Look of Windows Explorer

Windows Explorer, EclipseNT's file manager, can be displayed as a list or with large or small icons. I prefer to view my EclipseNT files in a list with details. Here's how you can set that up if you don't have it this way already.

Open EclipseNT and click on the File Manager icon or the speedkey *CTRL-F* to open the Windows Explorer. Now click on *View* and click *Details*. To make all folders in Windows ME and Windows 2000 appear this way, while still in the Windows Explorer click on *Tools* and *Folder Options* and then click the *View* tab. (In Windows 95/98 the Folder Options is on the View menu, so click on *View* and *Folder Options* and click the *View* tab). Next you click on the button that says *Like Current Folder*. Click *Yes* to confirm and then *OK*.

Now when you open up the Windows Explorer it will display your EclipseNT files in a list with file size, type, etc. which to me is much easier to work with than the icons view.

Keith's e-Tip

An Internet-Savvy Decimal

How can you define the steno you use for a decimal point so that it can serve as a "dot" stroke for Internet addresses like EclipseNT.com?

A conflict would work just fine. Define it as `\{DECIMAL}\{^}.{^}` When you've done this, use your familiar decimal point steno to write the "dot" in a phrase like "Butterflies.net". You'll probably need to select Choice 2 to resolve this conflict, but EclipseNT will instantly learn a grammar rule that's implicit in your editing. You may well find that when you use this same steno stroke to write a number like 3.2, EclipseNT immediately understands it to be a decimal point.
